POSITION SUMMARY: Greenwood is seeking several ministry residents who will serve in our Ministry Residency Program while they are a part of a cohort that works together towards spiritual formation and leadership development. The worship ministry resident will work closely with the Director of Worship Arts and the worship arts team to develop and grow the skills necessary for effective worship leadership and creative ministry within the local church context. This role is designed to provide hands-on experience, mentorship, and opportunities to lead and support various aspects of worship, music, and creative arts ministries. The goal of the residency is to equip the resident with the theological, musical, and technical foundation needed for long-term ministry in worship and arts.

QUALIFICATIONS:

- A Seminary graduate student pursuing a vocation in pastoral ministry
- Maintain full agreement with Greenwood's Mission and Values, Policy on Marriage and Sexuality, and the Evangelical Presbyterian Church (EPC) Essentials of the Faith
- A vibrant and loving faith in Jesus and an eagerness to grow in discipleship to Him
- A teachable spirit and desire to be equipped for ministry
- A love for people and a passion to help others grow in Christ
- A commitment to engaging in the life of Greenwood as a whole
- Relational, enthusiastic, positive, and hard-working
- Willing to take initiative and try new things

RESPONSIBILITIES:

1. Worship Leading and Planning:
 - Collaborate with the Director of Worship Arts and Lead Pastor to plan weekly

worship services, special events, and seasonal services.

- Co-lead worship gatherings, gaining experience in various styles and formats of worship.
- Assist in song selection, liturgical elements, and service flow to create meaningful worship experiences.

2. Worship Arts Production

- Participate in rehearsals, preparing musical and technical elements for worship.
- Support the setup, teardown, and operation of audio, visual, and lighting equipment.
- Work with the worship arts team to develop visual and artistic elements that enhance worship services.

3. Team Development and Pastoral Care

- Help organize and lead team meetings, training days, and prayer/worship gatherings for worship and tech teams.
- Build relationships with volunteers, assisting in their spiritual growth and skill development.
- Assist in recruiting and onboarding new volunteers for the worship and tech ministries.

4. Special Projects

- Plan and lead worship for additional gatherings as assigned, such as youth services, worship nights, or community events.

DEFINITION OF THE MINISTRY RESIDENCY PROGRAM:

By definition, the Residency Program is an internship and contains the following:

1. *Supportive ministry training similar to that available in and through schooling for future clergy.*
2. *This training is for the benefit of the trainee.*
3. *Resident is not a replacement for a regular employee but works under close observation.*
4. *This program is considered to be of greater value to the trainee than to the employer.*
5. *Participation in this program does not entitle trainees to future employment with the participating ministry.*
6. *Employer and trainee understand that trainees are not entitled to wages for the time spent in training.*
